Presenter: Kenneth Pfeil, Chief Data Officer

Discussion: Ken Pfeil gave an overview of the growth and accomplishments of ODGA within the last year. The agency increased from 8 to 24 team members and outgrew two office locations. In correlation to this growth, the Commonwealth Data Trust increased from 16 agencies to 32 agencies; of those consist of 26 executive branch agencies. Information was given about the ODGA roadmap and key areas of focus. The ODGA has been heavily engaged with the governor's initiative "Operation Bold Blue Line (OBBL)" by collecting violent crime data directly from 13 localities. Mr. Pfeil discussed the strategy of ODGA planning and the key results that are driven by it. The ODGA is hosting a Datathon themed "Unmasking Maternal Mortality". This will allow teams to utilize data provided by the ODGA to develop innovative solutions.

Discussion: Chris Burroughs introduced herself to the commission and began with the progress that ODGA accomplished since joining the agency; including the increase of inventory and metadata. Multiple internal and external policies were created to improve security and reduce risks. In addition, a

multidimensional training program was announced to improve data governance and data literacy knowledge across the Commonwealth. Included, Dataversity will allow one year of unlimited access of data governance training to 25 Commonwealth Data Trust members. The ODGA partnered with DMV to create customized data owner, data custodian, and data steward training. Data quality and unstructured data will be a focus of ODGA in the future. Next steps include short-term and long-term goals for the agency.

Presenter: Nick Thornton, Deputy Chief Transformation Officer

Discussion: Nick Thornton introduced himself and gave an overview of the Chief Transformation Office and began to discuss his experience collaborating with ODGA. A task was given to create a dashboard with DMV to provide an overview of agency and performance efficiency. Prior to ODGA's involvement, the Chief Transformation Office utilized a manual, time-consuming method to export files daily to retrieve information needed. This method ultimately made it difficult to provide accurate results and demanded at least one hour a day. After discussing this process, ODGA agreed to create executive level, automated dashboards through PowerBI platform. The outcome produced scalable, visually effective, highly efficient and dynamic, and user-friendly dashboards that saved the Chief Transformation Office and DMV executives significant time.

Key Points:

• Comment from the Honorable Emmett Hanger, Senator of the 24thDistrict of the Commonwealth of Virginia — an inquiry arose about how the ODGA ingests work throughout their growth alongside other agencies.

Mr. Ken Pfeil, *Chief Data Officer of the Commonwealth of Virginia* – in sum, the ODGA will sometimes take responsibility of priorities and tasks from other agencies to complete it in a more efficient manner. Within the next three years, the ODGA growth will probably level out around 30 people.

- Comment from the Honorable Emmett Hanger, Senator of the 24thDistrict of the Commonwealth
 of Virginia there could be a uniform system for the ODGA to be involved with the Secretary of
 Labor's expenditure on computers, contractors, and software.
- Comment from the Honorable George Barker, Senator of the 39th District of the Commonwealth of Virginia Workforce Data Trust was developed during General Assembly and can be a central point of how data is integrated.
- Comment from the Honorable Emmett Hanger, Senator of the 24thDistrict of the Commonwealth of Virginia A requirement of agencies to participate in the Commonwealth Data Trust from a "top-down" perspective is ideal. If data is available, it will be easier for individual agencies to access it in a secure manner.
- Comment from the Honorable Danica Roem, *Delegate of the 13th District of the Commonwealth of Virginia* A recommendation was given to reconvene after elections and have a legislative agenda meeting to get real-time feedback from legislators regarding a discussion for patrons to carry specific bills. This will provide a nonpartisan approach and less hesitation based on the amount of bills currently being endorsed.
