Discussion: Ken Pfeil began the discussion informing everyone the origin of the Data Management Maturity Assessment was recommended in the last VDAC meeting. The outcome brought awareness to agencies of how they deal with data on a day-to-day basis. This self-assessment consisted of 30 questions focused on people and culture, data activities, business process, and technology.

Discussion: Jocelyn Bagby gave an overview of the relationship that was developed between Virginia Department of Emergency Management and the Office of Data Governance and Analytics to build a customized business process automation that reconciled data sets from three disparate systems. This was used to reallocate payroll expenses to authorized funding for disaster response. Previously, the old process was manual and depending on the duration of disaster and volume of payroll, it would take accountants 1-3 weeks to complete. The automation tool created by the ODGA ultimately reduced this time to less than 1.5 hours.
